Re: Budget-Related Legislation

Dear Speaker McCall:

We urge you to reconvene the House as soon as possible to take action on unfinished budget-related legislation, including non-preferred appropriations, gaming reforms, and the authorization of table games.

The Senate has already approved two gaming reform bills and sent them to the House for its consideration: Senate Bill 711 on July 7 and Senate Bill 1088 on October 9. The Senate also has approved a bill to authorize table games, Senate Bill 1033 on October 9. Unfortunately, the House has not sent any of these bills to the Governor or returned them to the Senate with amendments.

The non-preferred appropriations bills represent \$730 million. There is simply no good reason to withhold this critical funding. This is especially true for funding related to Temple University, the University of Pittsburgh, Lincoln University, and Pennsylvania State University.

These non-preferred appropriation bills can be enacted into law based on current revenues, even without the \$200 million anticipated from table games. The Governor's Official General Fund Revenue Re-Estimate of October 9 (copy enclosed) projects a sizeable year-end surplus - far exceeding the \$200 million not yet realized due to the delay in authorizing table games.

To the extent the House believes table games legislation may be necessary to fund some portion of the non-preferred appropriations bills, there is no reason to delay passage of non-preferred appropriations bills totaling more than \$200 million.

If the House does not return to session until November 9, it will have been a full month since the General Appropriations Act was signed by the Governor, then 101 days late. Any further delay in finishing the remaining budget-related legislation is completely unjustified.

The Senate is currently scheduled to be in session on Monday, October 19, and Tuesday, October 20. The Senate will return to session immediately upon the House taking action on these critical, budget-related bills. We look forward to hearing from you.






Dear Governor Rendell:




